### **Phony** proposals target small businesses

Businesses are targets for scams each year and scammers are getting sav-vier in their schemes. If you are a small busi-ness owner, you are always looking for new clients. An RFP (request for proposal) sent to your inpor RFP (request for proposal) sent to your inbox can be a great chance to win new business. However, the BBB is warning businesses to be cautious of scam emails that only look like RFPs.

A business may receive an email with the subject "DFP Pronosal" or some-

"RFP Proposal" or some thing similarly general. thing similarly general. The message appears to be from a potential client asking the business to bid on a new contract. The first goal is to get the business to open the message and download the attached RFP like in most cases the at. file. In most cases, the at tachment seems "real." The RFP will include details about the project and uses a company or government agency name. The actual scam takes many forms. It may point you to another website to

input personal informa tion or request that you download a malware-infected file. Other versions request that you provide bank account information, under the guise of needing payment information. No matter what the con, the BBB recommends that you

delete it.

The BBB offers the following tips to help spot an RFP scam:

lowing tips to help spot an RFP scam:

• Don't believe what you see. Just because an email looks real, doesn't mean it is. Scammers can fake anything from a company logo to the "Sent" email address.
• Call the contact information to confirm. If you aren't sure if an RFP is real, reach out to the provided contact information. If this person doesn't exist or refuses to speak with you, it's a huge red

exist or refuses to speak with you, it's a huge red flag. Scammers often make excuses such as being "out of the country."

• Get outside confirmation. Scammers often pose as government agencies or use real company names. Check that the RFP is postad on the organization's ed on the organization's website. If the company doesn't list RFPs online, call their office to confirm. But don't use a link or phone number provided in the potentially phony

 Be cautious of gener-• Be cautious of generic RFPs. Scammers try to cast a wide net by including little specific information in their fake emails. Always be wary of messages and project descriptions that are overly broad.
• In genral, be wary of unexpected emails that contain links or attachments. Do not click on

ments. Do not click on links or open files in unfa

miliar emails.

Be extremely cautious, especially if this is not your normal process for getting new clients.
